Tax Rate 2014: \$0.1207/\$100


Tax Rate 2015: \$0.1283/\$100

**RESOLUTION**

At a lawfully called meeting on 15<sup>th</sup> day of September, 2015, and in accordance with Chapter 551 of the Texas Government Code, the Board of Directors ("Board") of the Crosby County Hospital District ("District") does hereby make the following resolution regarding the 2015 tax rate.

**WHEREAS**, the District is a government entity within the State of Texas;

**WHEREAS**, the voters of Crosby County elected to create the District and approve the District's levying of property taxes of up to \$0.30 cents per \$100.00 valuation;

**WHEREAS**, this year's tax levy to fund maintenance and operations expenditures does not exceed last year's maintenance and operations tax levy;

**WHEREAS**, the District's Board of Directors has determine it is the best interest of the District, its patients, and the resident of Crosby County that taxes be levied for the year 2015; and,


**WHEREAS**, the Board has determined a tax rate of \$0.1283 should be levied;

**NOW, THEREFORE**, be it resolved by the Board of Directors of the Crosby County Hospital District that the Board hereby adopts the above recitals as finds of fact and operative provisions hereof;

**BE IT FURTHER RESOLVED**, that the tax rate of \$0.1283 is hereby adopted; and,

**BE IT FURTHER RESOLVED**, that the District hereby has the authority to take such action as necessary or required to levy taxes as contemplated herein.


